Founded in 2017 by Neighborhood Preservation Inc. and the University of Memphis Cecil C. Humphreys School of Law, the Strategic Code Enforcement Management Academy (SCEMA) is an educational enterprise designed to build the capacity of leaders engaged in the creation, administration, and enforcement of housing and environmental code. We seek to enhance the health, safety, wellbeing and sustainability of neighborhoods by offering professional development and technical support through virtual lectures, trainings and individualized consultation.

The Academy is the only national code enforcement training that centers coordination and collaboration at the community level. The two-day summer event is filled with workshops and networking opportunities, helping cities to implement strategic code enforcement solutions that involve the collaborative efforts of multiple branches of local government and cross-sectional partners to ignite new policies, programs, and procedures to advance neighborhood preservation.
